

Lone Star Camp - Camp meeting Rules and Regulations

Lone Star Camp is owned and operated by a Christian organization. All lifestyles and behavior must reflect the principles of Christian living. For your safety and the protection of others your cooperation is greatly needed. Failure to comply with the rules and regulations set forth, will result in your immediate removal from Lone Star Camp premises.

You are responsible to read, understand and comply by the following guidelines:

- 1. All drivers are responsible to instruct their passengers of the rules and regulations of Lone Star Camp.
- 2. To enter legally on our premises, one must enter at the main gate, off FM 317. Any other entry point will be considered trespassing and will □be handled as such.
- 3. All vehicles must check in with security at front gate. To ignore this, could be grounds for your dismissal from the camp.
- 4. All campers must register for Lone Star Camp occupancy at Registration Headquarters.
- 5. All campers and staff must register their vehicles at the Registration Headquarters.
- 6. Off campus commuters who will be attending the camp daily must receive a free campus pass.
- 7. Auto and other motor vehicles are to be driven only by licensed drivers. The speed limit is 10 mph.

- 8. The camp is not responsible for personal loss, damages or theft to your vehicles or in your dwelling place.
- 9.LSC curfew is 11:00 pm (Sunday-Friday) and 1:00 pm (Saturday) All campers are strongly urged to observe the curfew that has been □established during our encampment. Please be considerate of others.
- 10. No campers should take the liberty of setting up camp (cabin, RV's or tents) without first checking with designated staff for proper □assignment Registration Headquarters on campus.
- 11. Additional beds may be ordered at Registration Headquarters. No other furnishings are to be removed from another tent or cabin.
- 12. Animals, pets and livestock are not to be brought on campground premises.
- 13. No use of alcoholic beverages, illegal drugs or substances is permitted according to federal law.
- 14. All outdoor cooking must be done on a stand barbecue grill or propane stove, with fire extinguisher nearby.
- 15. All RV campers are required to have a fire extinguisher.
- 16. No smoking is permitted on camp premises.
- 17. No littering. Trash must be placed in plastic trash bags. Everyone is expected to keep their dwelling litter free. Trash bags are to be tied and □placed in the dumpster provided in each camp area.
- 18. No unauthorized selling is allowed on the campground; unless permission is granted by SWRC Administration.
- 19. Lost and found items on the campground should be promptly brought to Registration Headquarters.
- 20. Dress code- attire that does not reflect Christian modesty or decency will not be tolerated on Lone Star Camp premises. One piece swim wear □is required and/or a T-shirt.

21.	No verbal or physical sexual harassment, no taunting, threats, intimidation or bullying, no fighting of any kind.
22.	No verbal or physical disrespect to camp guides or staff.
23.	No literature or religious material is to be distributed on the premises or vehicles without proper authorization by SWRC Administration or □Camp Superintendent.
24.	Campers are not allowed to carry or use firearms on Lone Star Camp premises.
25.	All knives on the premises must be within the legal Texas State Camp regulations concerning firearms and weapons. The legal blade length \Box in Texas is 5.5 inches long, except for cooking and fishing knives.
26.	No defacing, spray painting or destruction of camp property (including wildlife, trees, building, etc.) All violators will be held accountable □and liable.
27.	No swimming on camp premises unless approved by LSC Waterfront Director. NO EXCEPTIONS.
28.	No fishing or other water activities allowed without life preservers. Violators will lose all lake privileges.
29.	Water crafts, (boats, canoes, paddle boats, rafts, floats, etc.) can only be used with proper authorization from the Lone Star Camp Waterfront □Director or SWRC Administration.
30.	No parking, no stopping, no standing on camp roads or curb-sides. All camp roads are used as fire and emergency lanes. Parking is permitted only in designated areas.
31.	Children and youth that attend Campmeeting must be left under the responsible custody of an adult 18 years or older. The Southwest □Region Conference will not assume responsibility for youth and children who are independent of guardianship. Children 11 and under □cannot be at lakeside without adult supervision.

32. Each campsite, cabin, and/or RV area is to be cleaned up by the

residing camper(s) before vacating the premises of Lone Star Camp.

Special Instructions regarding children:

- *Children from ages 4 and under must be in the care of the parents or guardians at all times. Staff members cannot be responsible for the care and keeping of infants and toddlers.
- *Children between the ages of 4-10 must wear an ID band to match the parent or guardian when being dropped off or picked up. Any child without an ID band must remain in the custody of the parent for the entire meeting.
- *Children are to be picked up from the Kid's World area by 12:14 p.m. Failure to do so will result in the loss of ID band privileges. Consequently, you will be responsible for the custody of your child or children at all times.
